Main Points:

Competition Report:

Open water: The 2015 MSABC Provincial Open Water Swimming Championship will be held at

Thetis Lake for the 3<sup>rd</sup> year. Open to other areas of BC next year.

Pool: 12 meets were sanctioned for 2014-15.

### Insurance Report:

A reminder was given to clubs to apply to MSABC for their pool insurance certificate and not to go directly to Swim BC.

## President's Report:

Gilles answered the question "What does MSABC do for me and my club?"

- Sanctioning of 12 meets
- MSABC Open Water Championships held at the end of July
- MSABC Provincial Swimming Championships held at the end of April.

## Registrar's Report:

Rod Carmichael displayed 3 membership graphs for this past year:

- 1. Swimmers by gender 800+ Female, 600+ male
- 2. Swimmers by age 19 to 90+ with the majority of swimmers in the 30 55 age brackets.
- 3. Registration by Club Assistant

## Club Assistant benefits are:

- The entrants are responsible for what is entered in the meet.
- The entries go directly into HyTek.
- The entry money goes to MSABC in advance. Club Assistant charges a fee and as well, there is an additional fee to process credit cards. MSABC paid these fees this year. However, the board decided that it would pass this fee on to the hosting clubs in the future. Len is comparing prices of one day meets and multi-day meets. The board will set a rate after the analysis. The host club will be responsible for an approx fee of \$2.00.

## Communications Report by Susan Simmons

- There are 300 Facebook members
- There were over 3000 views on the Blog
- There were over 3000 visits to our store
- There were numerous stories about non-competitive and competitive swimmers on the Blog posts. Gilles and Susan attended the MSC conference in Toronto. All of the other provinces were impressed with what MSABC is doing. MSABC is looked upon as a leader.

# Treasurer's Report: by Keith Kendal

Keith broke down the expenses: AGM costs, Board meeting costs, Banquet costs, other meeting costs, competition costs, on line meet processing fees.

There was a drop in revenue this year due to fewer members. Yet MSABC had lower expenses this year. Operationally, there was a surplus of \$4,180 for the year ending August 31, 2014. Net current assets are \$87,744.

#### **NEW BUSINESS**

# 1. Vancouver Foundation Contribution: reported by John McManus

After reviewing the Treasurer's report, we have \$85,000. We need an annual working capital of \$30,000 to handle at least 6 years of losing \$6000 per year. The Board presented a motion to provide an irrevocable contribution of \$50,000 to the Vancouver Foundation. John McManus and Keith Kendal spoke in favour of the motion and explained the board's rationale for this course of action . In 2010, MSABC had previously provided an irrevocable contribution to the Vancouver Foundation of \$20,000. There was a discussion on the motion, following which the vote was called.

**MOTION** was defeated: 13 in favour; 14 opposed.

A further motion to contribute \$25,000 to the Vancouver Foundation was made by Brenda Clarke (Nanaimo Ebbtides) seconded by Brent Hobbs (Okanagan Masters)

Motion carried: 15 in favour; 10 opposed.

# 2. Appointment of Auditors for 2015-2016

Karina Younk (Ebbtides) was appointed An additional member volunteered, but she carried out the function in the year 2014-15 so is not eligible to do it in a subsequent year. The new President will be responsible to ensure a replacement is named, and that name will be included in a note to these minutes.

#### ITEMS FROM THE FLOOR

- 1. Jim Scantland thanked both the outgoing board Members and the incoming Board members.
- 2. Jim Scantland was concerned that Alberta Masters held their Provincial Championships on the same weekend as MSABC. He suggested that there should be a better liaison between the provinces in determining their dates for Provincials. Members of the MSABC Board explained that Alberta Masters is a sub-set of the Swim Alberta swimming organization. Swim Alberta made a unilateral decision to run their Masters Championships in Grand Prairie the same weekend as the BC Championships and failed to advise Alberta Masters as to when their provincials would be until just before the meet.
